President Moulds called the meeting to order at 4:05 p.m. *Member Jeys made a motion to approve the minutes of July 15, 2019 and Member Schultz seconded. The minutes were approved by a 3-0 vote.*

Mrs. Stuckert gave an overview of the project indicating the applicant is requesting approval for a resubdivision plat for Lot 107 and residue parcels A and B. Meadows at Town Run received Planning and Zoning approval in 2017 for a 107 lot subdivision. Since final approval, phase one of the subdivision has begun development. Phase two contains an existing home on lot 107 which is being sold and needs a boundary line adjustment however in doing so, the lot lines for residual parcel A will change. This is what is triggering the requirement for a re-subdivision.

Member Jeys asked if Lot 107 would be reduced or expanded in lot size. Mr. Jim Gotsch indicated the lot lines for lot 107 would be expanded to the actual property line of the subdivision which splits residual parcel A into two separate parcels. This creates a residual parcel A and B.

President Moulds entertained a motion. Member Schultz made a motion to approve the requested re-subdivision plat for Lot 107 and residual parcels A and B of the Meadows at Town Run Subdivision for Case No. 100-15A and Member Schultz seconded. The motion passed by a 3-0 vote.
