 Phase 2 (2) contains 47 single family home lots, a pavilion, play field, and playground area for outdoor activities and open space. Phase two (2) only contains two additional roads; Daffodil Court and Meadow Street. Meadow Street will be stubbed for future connection to the Wathen Farm at a future date. Today, the applicant is requesting plat approval for Phase 2 of the subdivision.
